ORDER OF RESTITUTION

On January 23, 2013, this cause came before the Court on a hearing held in accordance with Ark. R. Civ. P. 55(b) to determine the amount of funds received by Defendants Samuel L. Anderson, Jr., and P-R-E, LLC and establish the amounts of restitution and fines to be ordered in this case, and based upon the evidence and testimony presented at the hearing, the Court does hereby find and order as follows:

1. Defendants Samuel L. Anderson, Jr. and P-R-E, LLC, or either one of them, shall pay restitution in the total amount of \$1,550,750.00 into the Registry of the Pulaski County Circuit Court within three calendar years of the entry of this Order. Such payment shall be: (a) made in bankable funds, i.e., by United States postal money order, certified check, bank cashier's check, or bank money order; (b) made payable to the Pulaski County Circuit Clerk; (c) hand-delivered or mailed to the Pulaski County Clerk's office, 401 West Markham Street, Room 122, Little Rock, Arkansas 72201; and (d) submitted under cover of a letter that denotes the file number of this case and identifies the payment as being made in accordance with this Order. A copy of the cover letter and money order or check shall be sent to A. Heath Abshure, Commissioner, Arkansas Securities Department, 201 East Markham, Suite 300, Little Rock,

Arkansas 72201. Once received, these funds shall be distributed by the Pulaski County Circuit Clerk in accordance with the investors and amounts listed in Schedule "A" which has been attached hereto and is incorporated as part of this Order.


2. Defendants Samuel L. Anderson, Jr., and P-R-E, LLC, or either one of them, shall pay a civil money penalty in the total amount of \$253,500.00 to the Arkansas Securities Department within five calendar years of the entry of this Order. Such payment shall be: (a) made in bankable funds, i.e., by United States postal order, certified check, bank cashier's check, or bank money order; (b) made payable to the Arkansas Securities Department; (c) hand-delivered or mailed to the Arkansas Securities Department, 201 East Markham, Suite 300, Little Rock, Arkansas 72201; and (d) submitted under cover of a letter that denotes the file number of this case and identifies the payor as a defendant in these proceedings.

3. This Order shall be given preclusive effect in any bankruptcy case filed by or against the Defendants Samuel L. Anderson, Jr., or P-R-E, LLC. Solely for the purpose of such bankruptcy proceedings, this Order establishes all the elements necessary to enable a court to make a finding that it is non-dischargeable pursuant to 11 U.S.C. §§ 523(a)(4) and 523(a)(19).


