**AGREED ORDER**

---

On this day this cause came before the Court following the entry of a partial default judgment against the Defendants on May 7, 2015, as to liability for the causes of action respectively levied against them in the Complaint, and based upon a subsequent agreement of the parties as to the amount of funds received by the Defendants and the amounts of restitution to be paid by the Defendants in this case, and the submission of this Agreed Order to that effect, the Court does hereby find and order as follows:

1. Defendants SKB Partners, LLC; Maverick Investments, LLC; and Scott A. Smith; or any one of them, shall pay restitution in the total amount of \$725,000.00 into the Registry of the Pulaski County Circuit Court by no later than 5:00 p.m. on May 1, 2018. The Defendants shall be allowed to make monthly or periodic payments during the intervening time period in order to satisfy the total amount by the deadline date. All payments shall be: (a) made in bankable funds, i.e., by United States postal money order, certified check, bank cashier's check, or bank money order; (b) made payable to the Pulaski County Circuit Clerk; (c) hand-delivered or mailed to the Pulaski County Clerk's office, 401 West Markham Street, Room 122, Little Rock, Arkansas

72201; and (d) submitted under cover of a letter that denotes the file number of this case and identifies the payment as being made in accordance with this Order. A copy of the cover letter and money order or check shall be sent to B. Edmond Waters, Commissioner, Arkansas Securities Department, 201 East Markham, Suite 300, Little Rock, Arkansas 72201. Once restitution is received in full, these funds shall be distributed by the Pulaski County Circuit Clerk in accordance with the investors and amounts listed in Schedule "A" which has been attached hereto and is incorporated as part of this Order.


2. This Order shall be given preclusive effect in any bankruptcy case filed by or against the Defendants SKB Partners, LLC; Maverick Investments, LLC; or Scott A. Smith. Solely for the purpose of such bankruptcy proceedings, this Order establishes all the elements necessary to enable a court to make a finding that it is non-dischargeable pursuant to 11 U.S.C. §§ 523(a)(4) and 523(a)(19).
